Important Information

Data protection regulations mean that we require signed copies of this form from all adult members. If you have couple membership, then you both need to sign. If you wish to send your signed forms electronically, they should be emailed to braund@one-name.org. They must contain an actual signature, not a typed one. You are signing to acknowledge that you have read the statements below. If you are not comfortable signing for any reason please let us know. If you have signed this form in a previous year we do not need another copy.

If you wish to pay by BACS, or if you are paying by standing order for the first time, it is essential that you contact braund@one-name.org or send details to Janet at the address overleaf. Our transaction level means that we only receive statements very infrequently, so it could be several months before we realise that you have paid if you do not inform us. Please include your surname and postcode as a payment reference. Equally, please let us know if you cancel your standing order.

GENERAL DATA PROTECTION REGULATIONS

Your details are used to send out your journal, if the Society needs to contact you for administrative purposes and to send you information relevant to your Braund family history.

1. The following information may be held on the membership secretary's computer and back up hard drives: Your name(s), address, postcode, email and telephone number if you have provided them, the branch of the family to which you belong and years of membership. Your contact details and the branch of the family to which you belong, will be listed in the journal when you first join, unless you specifically ask us not to do so. Your name and contact details may be held by the organiser, in connection with a Braund reunion in which you have expressed an interest.
2. Articles submitted for publication in the Braund Society journal may include your name and home town. Additional contact details will only be published if you have asked for this to be done, to enable other readers to contact you for example.
3. Your email or address is used to send you no more than two reminders for an overdue subscription.
4. Apart from information contained in journal submissions, any family information that you provide is used exclusively to enable us to identify how you fit in to the wider Braund family and to further our research in to that family.
5. Those who have opted in to our DNA project will have their results held on a single computer for analysis purposes. Your name will not be published or passed on in connection with these results unless you have given permission.
6. If you have sent us photographs containing living people, we assume that you have sought permission from all those depicted and that these photographs are available for us to use in furtherance of our society aims and for no other purpose.

We only use your personal data for matters as listed above and will not disclose any information to a third party without your explicit permission.

For the duration of my membership, I agree to give the Braund Society permission to use the personal details that I have provided as outlined above. I am able to withdraw my consent to storage, processing and use of my data at any time by e-mailing braund@one-name.org or by writing to the current membership secretary whose address will be found on the reverse of the journal. My details will then be removed.
